2016 Needs Assessment Data Analysis Process: Harbolt reviewed the survey tool, qualitative analysis codebook and Sampling Summary as of May 18, 2016, see attached. She is working with DSHS to get surveys from individuals who are out of care. Their DIS workers are seeking those who appear to be out of care and when they locate them they call us to have them do the survey by phone. The City of Houston Health Department has also agreed to do the same. Vargas asked Mgbere if he had any participants that may be out of care in the Houston Medical Monitoring Project. He said they did not.

Principles for the 2016 Needs Assessment Analysis: See attached. Changes were made as follows: PLWHA was changed to PLWH; EMA was changed to EMA/HSDA; Add to the end of item 3.a.: (How to Best Meet the Need); and item 3.d. was moved to 3.b.; <u>Motion #2</u>: It was moved and seconded (Pruitt, Sierra) to approve the Principles for the 2016 Needs Assessment Analysis with the suggested updates. **Motion carried**.

Necessities, Hypotheses and Curiosities: What do we want and need to learn from the data?: Harbolt reviewed the Comprehensive Plan guidance regarding needs assessment. The workgroup identified the following as possible items for the needs assessment report: Turner would like to see a chart broken down by age with a list of needs for each group and also by age with barriers; keep the service category sheets with the population information on each; include information for each of the special populations from the 2017 plan; prevention information broken down by race, information that helps with the NHAS goals – information by race and age; look at the possibility of trends – such as were fewer barriers reported or what else has changed; information on those with HIV and Hepatitis C coinfection.

Next Meeting: The next meetings were set for June 6th at 10:00 a.m. and June 16th at 1:30 p.m.; agenda items include discussion of weighing data and revising report domains, and review and approval of the report.
