Call to Order: Ella Collins-Nelson, Co-Chair, called the meeting to order at 9:59 a.m. and asked for a moment of reflection.

Adoption of the Agenda: <u>Motion #1</u>: it was moved and seconded (Boyle, Galley) to adopt the agenda with the following change: move Critique the 2018 Council Orientation so that it is item III A. Motion carried unanimously.

Approval of the Minutes: The committee was unable to approve the minutes from January 18, 2018 since Skeet Boyle was the only member of the 2018 and the 2017 Operations Committee and he did not attend the meeting on January 18^{th} .

Public Comment: None.

Critique the 2018 Council Orientation: Harbolt reviewed with the committee the attached 2018 Council Orientation Evaluation Results. The Committee members were in agreement with the collective critique. At the 2019 Orientation, the committee would like to do the following: 1.) consider bringing a motivational speaker at lunch and 2.) have an activity similar to the 'dance' activity in 2018 (in an effort to give members an opportunity to stretch after lunch, Denis Kelly led the group in dancing the Hokey Pokey).
