New Business

Ryan White Parts A and B Organizational Documents: <u>Motion #3:</u> it was moved and seconded, (Starr, Kelly) to table reviewing and updating the Ryan White Part A Memorandum of Understanding and the Part B Letter of Agreement until the year 2022. Motion carried unanimously.

FY21 Budget: Because of a vacancy in the Health Planner position and the need to hire consultants to begin working on the 2022 Comprehensive Plan, <u>Motion #4:</u> it was moved and seconded, (Cruz, Kelly) to approve the attached revisions to the FY 2021 Office of Support budget.
