#### **Old Business**

**2023 Ryan White Membership Attendance**: Williams reported that, per Committee instructions, Office of Support staff sent letters to volunteers with poor attendance in 2023.

**Updates on Payroll Debit Cards:** Williams updated members that the Office of Support still needs to send a follow-up survey to the Council and Affiliate members who request petty cash reimbursement. The survey will inquire about those who wish to participate in the Debit Card Pilot Program.

MOU and LOA for Judge to sign: Williams informed the committee that the Memorandum of Understanding will be sent to the Judge to sign; see attached. The hold up has been trying to find the person at the Texas Department of State Services to sign the Letter of Agreement. There has been enormous turnover and Shelley Lucas was never replaced. All agreed to move forward with the MOU.

**Personnel Update:** Williams informed the Committee of her possible retirement plans and how they may impact the Council and staff. The first optimal option is for the Judge to separate the two jobs Williams is currently holding: Manager of the Office of Support and Liaison to the Judge. Williams would keep the Liaison position, work one day a week, and fill the Manager

position starting January 2024 with a new manager. If the Judge says no to separating the two positions, Williams will continue with the two positions and retire in August or September 2024.
