RE: Adjusting the 10% Reallocation Rule at Mid-Year

Currently, RWGA is allowed to move up to 10% of unobligated funds from one service category to another. In the final quarter of the grant year, RWGA is allowed to reallocate more than 10% of RWPC-approved service category allocations to ensure the Houston EMA/HSDA has less than 5% unspent Formula funds and no unspent Supplemental funds.

RWGA requests for RWPC consideration and approval to allow RWGA to shift funds more than the 10% reallocation rule to coincide with when agencies are permitted to submit their back billing requests in August. Agencies may submit back billing requests in August and February.

The justifications for this request are as follows:

- 1. It would allow for a more accurate accounting of true service category expenditures, which categories need more or less funds, and better inform the Council of client needs, especially at its mid-year reallocation determinations.
- 2. Allow RWGA to forecast year-to-date expenditures more precisely and inform the Council of such spending more accurately. Better forecasting is essential as it relates to over 5% of unspent Formula funds penalty, which, if reached, jeopardizes future supplemental funding.
- 3. Allow agencies to better allocate funds to services where more funds are needed and where the true costs of providing services reside.
- 4. Reduce the large bills RWGA receives in February from agencies that delay final payment and the close of the grant year.
 - 1. Delays in final payments become more significant beginning in FY24. Administrative Agents will only have 90 days to submit their Federal Financial Reports to HRSA instead of 180 days.

RWGA is undoubtedly respectful and appreciates RWPC's legislative role in prioritizing and allocating RW/A and MAI funds. As an internal control, we recommend receiving formal RWPC approval before shifting service category funds over and above 10% at mid-year.

TOPIC: RWB/State-Rebate Update

Effective April 1, 2023, DSHS has eliminated State-Rebate funding. State-Rebate will be consolidated with DSHS State Services. TRG issued a gap contract 4/1/23-8/31/23 to utilize the 5-months of remaining DSHS State-Rebate funding. Effective September 1, all services supported by State-Rebate will be funded through DSHS State Services. Service categories being added to State Services include Medical Transportation-Targeted, Food Bank-Targeted, ADAP/Referral for Healthcare, EFA/Compassionate Care, and Health Insurance Assistance.

- ADAP Referral for Healthcare- These funds are earmarked for the THMP/ADAP process. This project is a DSHS targeted project and therefore will not be a component of the P&A process.
- EFA/Compassionate Care- These funds are earmarked for the DSHS project to increase access to patient assistance programs. This funding will not be a component of the P&A process.
- MT-targeted/FB-targeted- these funds are targeted to the HOPWA Post-Incarceration Project. Eligible clients must participate in the TRG HOPWA program.
