Ask about the last appointment set. OR Ask about the previous 12 months.

Is it a routine or sick visit

Multiple choice or scale for answer choices

Include questions re grievance

Include phone #s at the end of the survey to call for info.

Suggested questions for the Needs Assessment:

Do you have your paperwork in order?

How long from the first documented request for service until the actual receipt of service. (from the draft wait time definition)

Have you been told you are on a waiting list?

How long did it take to get an appointment?

Did they tell you about wait time or wait list?

Was it during a busy season?

If you were initially denied an appointment, how long did it take to get one?

Do you know of other providers to access for this service?

Have you ever been put on a wait list or had a wait time that you considered unusually long? For what service and for how long did you wait?

Are you aware of stand by appointments?

How long is too long to wait?

Were you given alternatives to waiting?

Were you given and understandable reason for the wait?

Once an appointment is made, how long until the appointment?

Many are on a wait list for missing appointments. If you had an appointment but missed it, why?

Do you know who your CM is and how to access them for assistance?

Do you have a blue book?
