2004 COUNCIL ACTIVITIES – This Power Point presentation was provided by Diane Clark, Council Coordinator.

Call to Order: Steven Walker, Chair, Ryan White Planning Council, called the meeting to order at 11:50 a.m. by asking for a moment of reflection. There were fourteen members present, five short of a quorum. Therefore, the Council agreed to review FYI information until a quorum was established. Walker recognized the following Council members who had reached the end of their term limits: Veronica Garza, Albert McKinney and Kimbrae Sanders. Walker thanked them for their service and stated that he hoped they would apply to be external committee members in 2005.

Training: New Ryan White Planning Council Travel Reimbursement Policy. Walker and McNeese-Ward reviewed the attached the Travel Reimbursement portion of the Petty Cash Policy.

Reports from Committees:

Comprehensive HIV Planning Committee: Walker reported on the following: 2005 HIV/AIDS Needs Assessment: The final draft of the report will be available for review on Friday, December 17, 2004. The meeting to critique the document will be at 2:30 p.m. on Monday, January 5, 2005. Council approval will be sought in February 2005.

Advances in Medication & Treatment: Walker reported on the following:

Administrative Assessment Committee: Ainsworth, Vice-Chair, reported on the following: Reports from the Administrative Agent (see attached reports):

2005 Evaluation of the Administrative Mechanism: There was a discussion about making significant changes to this process at the November committee meeting. At 2:00 p.m. on Wednesday, February 2, 2005, the committee will continue the discussion. The Chairs of the Operations and Priority and Allocation Committees are encouraged to attend in order to provide input from their point of view.

Affected Community Committee: Lesley P. Williams, Chair, reported on the following: 2004 Committee Meetings: Over 13 residents from Corder Place attended the November Committee meeting. The residents had a number of questions about changes scheduled to occur with Title I services in FY 2005.

McNeese-Ward added that there was a great World AIDS Day Forum on Friday, December 3, 2004 that featured an African-American Male Panel. Garner and Jackson also had positive things to say about their participation in the the December 3rd event.

2005 Elections of Officers: Walker reviewed the election policy and then gave each candidate one minute to state why they felt they were a good candidate. *Motion 3: To accept the following slate of nominees running for office in 2005: Chair: Steven Walker; Vice Chair: Kevin Jackson, Ken Malone and Thomas Urban; Secretary: Johnetta Evans-Thomas, Kevin Jackson and Marlene McNeese-Ward (Nomination made from the floor by McKinney). Motion carried.* Walker reminded Council members that election ballots can be reviewed by anyone during or after the meeting.

Steven Walker was elected as the 2005 Chair of the Council by acclamation.

While the votes were being tallied, Walker presented each Council Member with a Certificate of Appreciation for their service in 2004.

Ken Malone was elected to be the 2005 Council Vice-Chair.

Since one of the officers must be a self-identified person with AIDS, McNeese-Ward withdrew her name from the slate of nominees for the Secretary.

Kevin Jackson was elected to be the 2005 Council Secretary.

2005 Council Orientation: The 2005 Council Orientation is scheduled for all day, Thursday, January 27, 2005.

CDC Planning and Prevention Group: Walker stated that McNeese-Ward has been selected as the new government representative. There are two chairs for the group, one is elected, and one is appointed. McNeese-Ward has been appointed to represent the Department of Health. Barbara Joseph will be the elected CPG Chair beginning on January 1, 2005.

Mayor's Task Force: Walker stated that the new State of Emergency Plan can be found on the website for the City of Houston.
